INFORMATION ABOUT PERSONAL DATA PROCESSING ACCORDING TO SECTION 13 OF LEGISLATIVE DECREE 196/2003

Dear Customer, pursuant to section 13 of the Legislative Decree 196/2003 (in the following called "T.U.") and in relation to the personal data, which are in the possession of Technai Team s.r.l., we hereby inform you about the following:

1. Aims of the data processing. Processing is finalised only to a correct and complete execution of the contract stipulated with you.
2. Methods of the data processing.
 - The data processing has been carried out by means of operations or a complex of operations indicated in section 4, subsection 1, letter a) T.U.: collection, recording, organisation, preservation, consulting, processing, modification, selection, extraction, comparison, utilisation, interconnection, blocking, communication, cancelling and destruction of the data.
 - The operations can be carried out with or without the aid of electronic or automated means.
 - The data processing has been carried out by the data controller and/or by the persons in charge of processing.
3. Providing of personal data. Providing of personal common data is strictly necessary for carrying out the activities according to point 1.
4. Failure to provide data. Any failure to provide personal data by the data subject in the case of point 3 will cause the impossibility to do all activities according to point 1.
5. Data communication. The personal data can become known to the persons in charge of processing and can be communicated for the scopes according to point 1 to external collaborators and in general to all those subjects to whom the communication is necessary for a correct fulfilment of the fixed goals according to point 1.
6. Data diffusion. The personal common data may be diffused only if this is expressly foreseen in the contract stipulated with your company.
7. Transferring of the data abroad. The personal data can be transferred to countries of the European Union and outside according to point 1.
8. Rights of the data subject. Section 7 T.U. confers to the data subject the exercise of specific rights. Among these the data subject shall have the right to obtain from the data controller the respective confirmation as to whether or not personal data concerning him exist and communication of such data in intelligible form. A data subject shall have the right to be informed of the source of the personal data, of the purposes and methods of the processing, of the logic applied to the processing, of the identification data concerning the data controller and of the entities to whom the personal data may be communicated. Furthermore, a data subject shall have the right to obtain updating, rectification or integration of the data, erasure, anonymisation or blocking of data that have been processed unlawfully. A data subject shall have the right to object on legitimate grounds to the processing of personal data.
